

Instructions for Preparing & Submitting Your Design Review Packet – Virtual Design Review Board (DRB) Meetings, Updated November 2021

Please follow these steps to prepare and send your Early Design Guidance (EDG) or Recommendation Packet to the Seattle Department of Construction and Inspections (SDCI). We require hard copies, electronic copies and a cover image. When developing your packet contents, please include all items identified in the Early Design Guidance, Streamlined Design Review and Recommendation packet checklists.

What we need and when:

- Digital Project Image: We will post an image of your project on our online map, <u>Shaping Seattle: Property & Building Complaints</u>. Please upload this digital image to Hightail for posting on the Design Review website following the instructions on page 2-3. See due date highlighted below.
- 2. **Digital Packet:** We will post your packet on our <u>Design Review website</u>. For all Full DRB and Administrative Design Review projects, please upload the final packet to your portal and also to Hightail following the instructions on page 2-3. See due date highlighted below.
- 3. **Final Packet, Hard Copies:** We will send your packet to the Design Review Board in advance of the meeting. The final packets are due on the Monday of the week two weeks prior to the scheduled meeting date for all Full Design Review Board (DRB) projects. (Note if Monday is a holiday, the deadline will shift to Tuesday). We will need **eight** hard copies of your final packet with guaranteed arrival at SMT before/on the date specified above.

- For courier/in-person drop offs, please address your packets to the first address listed above and bring them to the following location at Seattle Municipal Tower (700 5th Ave):
 - Finance & Administrative Services (FAS) Distribution Services, Suite 304 (from the 4th floor lobby, take escalator or stairs down to 3rd floor)
 - Use the telephone next to the FAS Distribution Services room sign to call the FAS Mailroom (using the programmed button) and request to have the packet picked up
 - o Hours: 7:30 AM to 3:00 PM

To create and send your image/packet:

1. Formatting:

Packet: Your design review packet should meet the following specifications.

- Formatted to fit 11"x17" paper size.
- Number your pages starting with the cover sheet.
- Use colored graphics.

Digital Packet: The .pdf version of your packet should look exactly like the hard copy version.

Digital Project Image for Shaping Seattle: The .jpg of your image should meet the following specifications:

TYPE:	JPG (*.JPG,*JPEG)
DIMENSION:	Width: 870 pixels
	Height: Variable
FILE SIZE:	Less than or equal to 150kb
IMAGE AT EDG	Image should include side-by-side images of the design thinking as shown
	by the various massing alternatives (include all alternatives in single image)
IMAGE FOR SUBSEQUENT	Image should be a snapshot of the evolved massing, loose design without
EDG MEETINGS	full rendering details
IMAGE FOR SDR	Image should be a snapshot of the rendering view
IMAGE AT	Image should be a snapshot of a rendering view that captures the
RECOMMENDATION	greatest extent of building (i.e., a corner view)

2. Saving:

You need to optimize your .pdf and .jpg.

- Save the packet as a single .pdf.
- Reduce the file size to 50mb or less wherever possible, while retaining the document's legibility on the screen and in print, using a page layout or graphics program. Adobe Acrobat DC's (or Pro's) "pdf optimizer" (File>Save as Other>PDF Optimizer) is often a good way to optimize your .pdf.
- The .pdf is best created from an existing electronic file. For those who prepare EDG and Recommendation packets and/or images without the use of a computer and page layout software, copy shops can scan a hard copy of a packet and burn a .pdf onto a CD.

3. Transmitting to SDCI:

- Upload your files by following the instructions at <u>www.hightail.com/u/dpd</u>
- Name your files as follows:
 - o For your **packet**: In the subject line, write "Draft" or "Final" "Design Proposal Packet for XXXXXXX-XX" (where XXXXXXX-XX is the project number assigned by SDCI).

- For your **image**: In the subject line, write "Design Proposal Cover Page for XXXXXXXXXXXXX" (where XXXXXXX-XX is the project number assigned by SDCI).
- For your **presentation**: In the subject line, write "EDG" or "REC" "DRB Presentation for XXXXXXX-XX" (where XXXXXXX-XX is the project number assigned by SDCI).

If you do not have web access, burn the .pdf file to a CD and mail it in with the hard copies of the final packet:
