- The site inspector shall receive a <u>fully executed Rat Abatement Certification (RAC)</u> signed by a licensed pest control agent <u>at the first ground disturbance inspection</u>. - 5. In addition to the RAC, bait stations or other evidence of an ongoing rat abatement program should be easily visible at the first ground inspection.
