


# **RAT ABATEMENT NOTICE FOR DEMOLITION PROJECTS**

For compliance with Seattle Building Code 3303.15 and Seattle Residential Code R107.12

## Demolition Permit No.: <u>6763821-DM</u> Address of Building to be Demolished: <u>1932 9TH AVE SEATTLE, WA 98101</u>

## The following requirements apply to this demolition permit.

- 1. Rat abatement must **begin at least 15 days before** first ground inspection and the start of demolition or the start of any clearing and grading activity.
- 2. Rat abatement **must continue** until the start of demolition.
- 3. This project must pass the first ground disturbance inspection before the start demolition or clearing and grading on this site.
- The site inspector shall receive a <u>fully executed Rat Abatement Certification (RAC)</u> signed by a licensed pest control agent <u>at the first ground disturbance inspection</u>. - 5. In addition to the RAC, bait stations or other evidence of an ongoing rat abatement program should be easily visible at the first ground inspection.
- 6. Site inspectors cannot waive the rat abatement requirement.

#### TO THE CONTRACTOR/OWNER,

Additional permits may be required for work occurring under this permit. This permit does not authorize Sewer, Public Right-of-Way Shoring, Drainage and Street Use, Fire Department, Boiler, Electrical, Elevator, Furnace, Gas Piping, Plumbing, or Sign permits. If other permits are required, they must be applied for separately from this permit. The requirements for all other permits related to this Permit, must be completed prior to the Final Inspection of this permit.

<u>This Permits Final Inspection is required.</u> The premises must not be occupied until the Final Inspection is provided and occupancy is authorized by the Seattle Department of Construction and Inspections.

#### INSPECTION REQUESTS:

Please clarify which inspections your project requires before proceeding with your project.

You may request an inspection on the internet or by phone. Inspection requests received **<u>before 7:00 AM</u>** are scheduled for the same working day. Inspection requests received **<u>after 7:00 AM</u>** are scheduled for the next working day. Inspectors are available between the hours of 7:30 AM and 8:30 AM.

#### **BEFORE BEGINNING CONSTRUCTION:**

A) Before First Ground Disturbance, request an inspection of installed Erosion Control Measures.

- B) When there is **Special Inspections**, Land Use conditions, and/or unusual design elements, a **Pre Construction Conference** is required <u>prior</u> to construction. Call 684-8860 to request a Pre Construction conference.
- C) If this permit requires a **Soil Bearing Capacity** special inspection by a Geotechnical Engineer, that approval is required **before** the foundation pour. The Building Inspector will accept the Geotechnical Engineer's approval **signature below**.
- D) When Special Inspections are required, notify the Special Inspection Agency at least 24 hours in advance.

#### **DURING CONSTRUCTION:**

Seattle DCI inspectors will provide a copy of each inspection report. These reports must either be kept with this Permit, or kept together where they can be conveniently referenced. Request an inspection for the following installations:
