Community Outreach Response Summary:

The comments received from the survey and community outreach meeting on the development mostly aligned to three themes; paying homage to Belltown's history, celebrating the Pacific Northwest landscape, and contributing as an upstanding and engaged member of the community.

There were requests to pay homage to Belltown's history through the building's artwork, with references to Cinerama, the elephant car wash sign, and artist John T. Williams. It was suggested that the building be designed to fit into the existing neighborhood. At the Community Outreach Meeting, one community member urged that the design respect the historic apartment building to the south.

Recommendations to celebrate the Pacific Northwest landscape came up in answers to our questions about what references the public would like to see in the building's artwork, and about what local qualities should be included in the building design. At the Community Outreach Meeting, one community member expressed appreciation for how the proposed exterior façade design will reference forest, water, and mountain. They also stressed the importance of designing for sustainability.

Responses encouraged the development to contribute to the community. It was suggested to provide street level interest, by creating an outdoor space at the street level that connects the indoor street level activities to the streetscape. At the Community Outreach meeting, one community member asked that the use of the alley and surrounding streets be designed to help reduce congestion on city streets. There was also an entreaty for the development to be a good neighbor.

The design team has listened to these comments and recommendations, and will continue to incorporate them throughout the design process in particular:

- We will draw on the recommendations to incorporate Belltown's history and the pacific northwest landscape as we design artwork for the building.
- The building is setback from the historic apartment building to the south.
- The proposed façade will reference the pacific northwest forests, water, and mountains.
- There will be an outdoor seating area on the street level for the proposed café.
- We are taking the impact the building will have on the alley and surrounding streets into consideration as we continue to develop the design of the street level spaces.

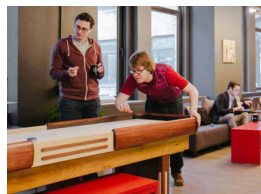

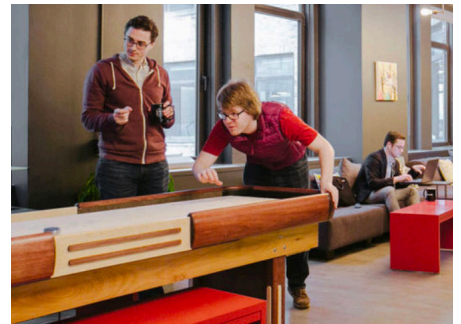

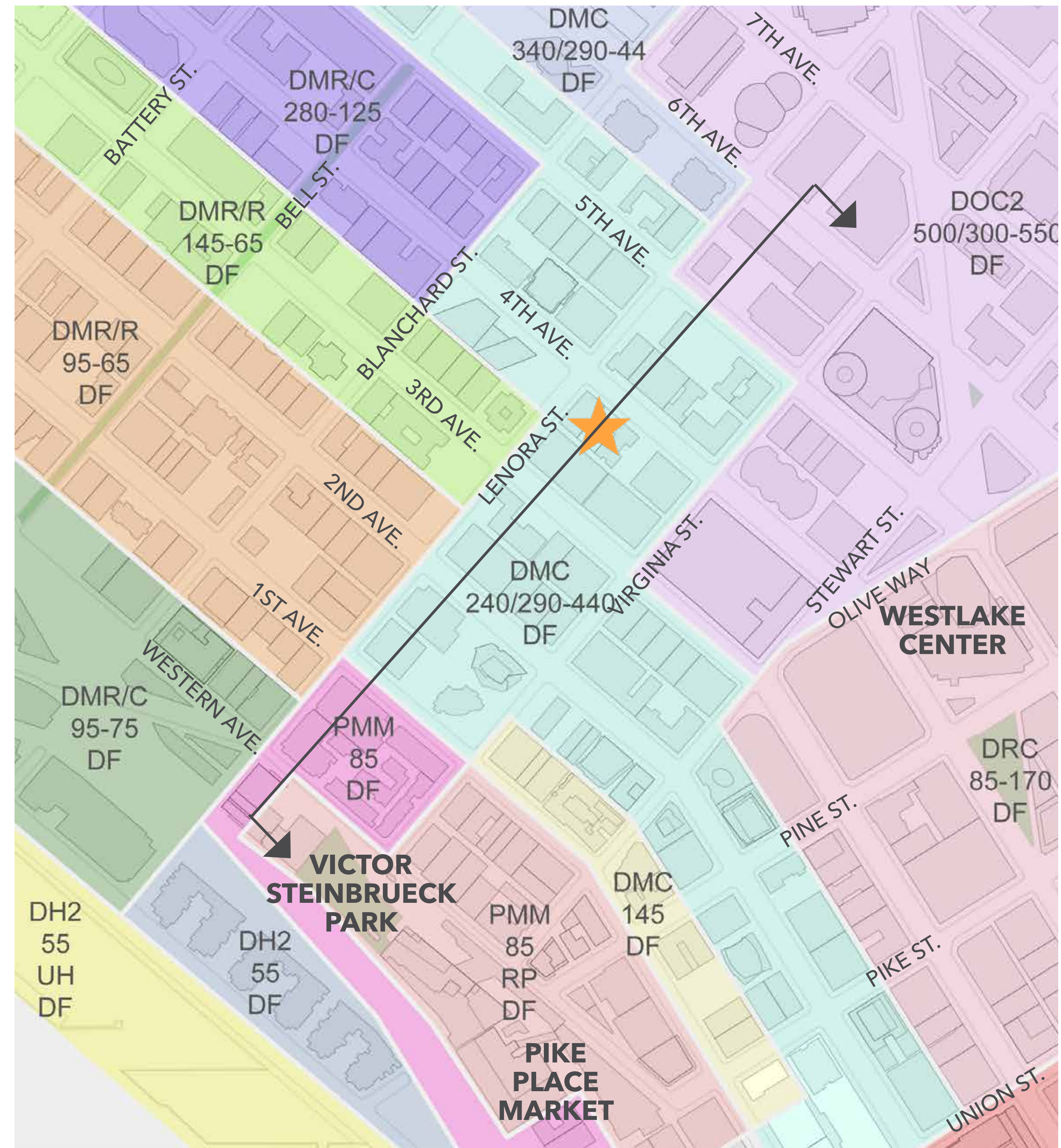
# SITE LOCATION PLAN

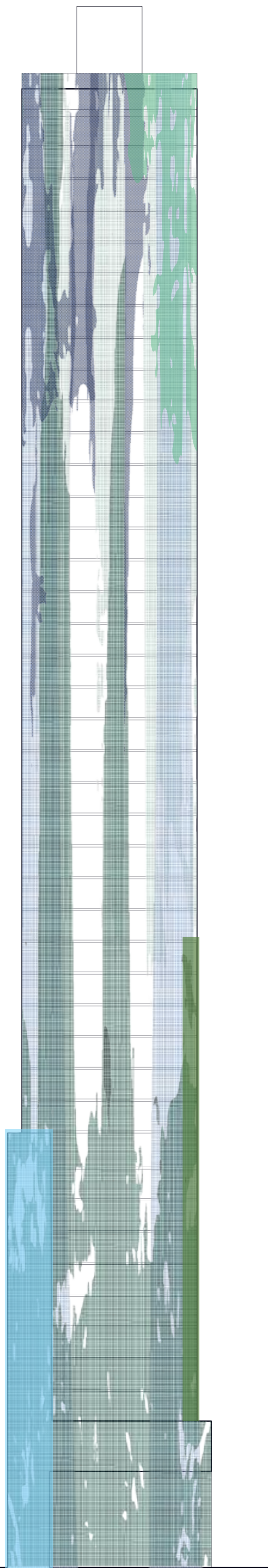

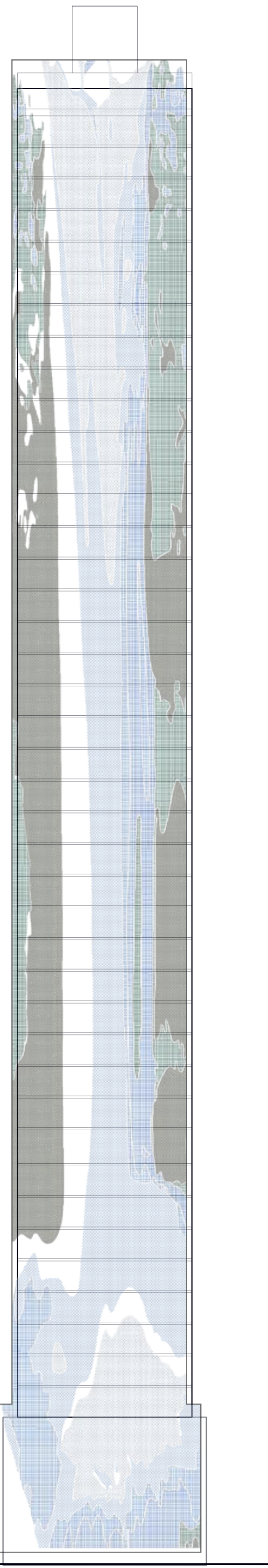

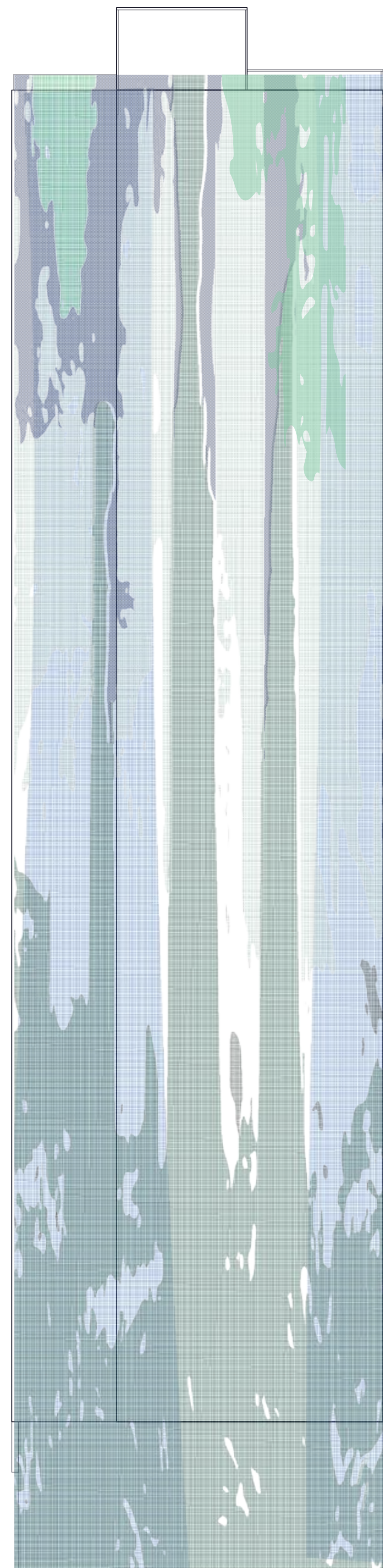

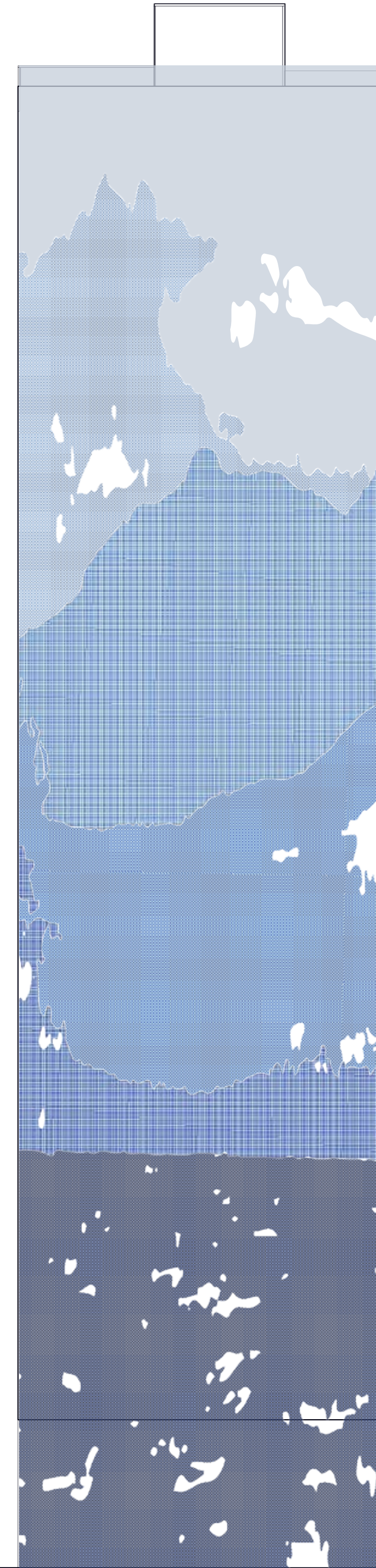

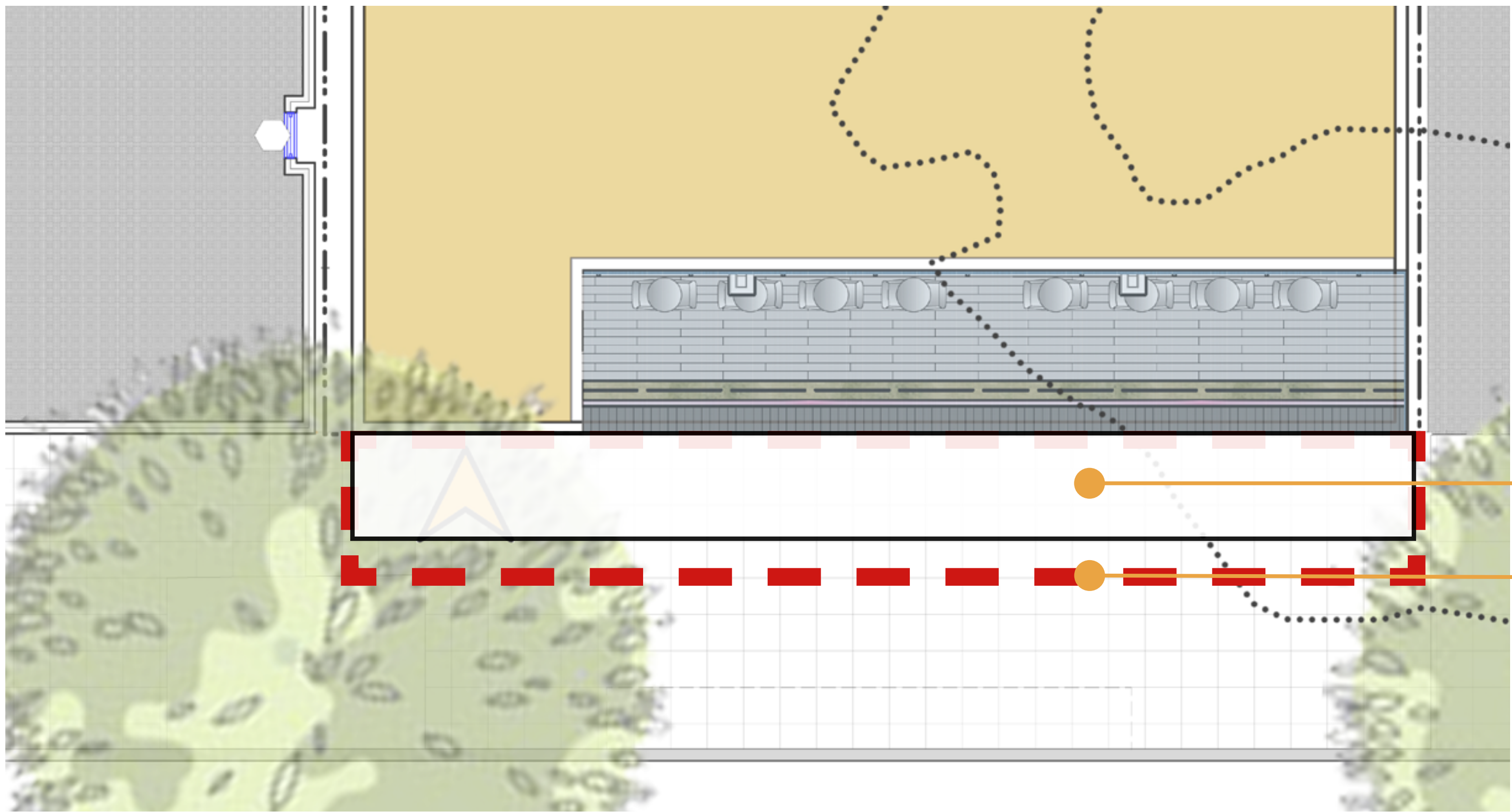

Regarding the mailing/outreach process you followed, I've seen it used twice now and it garners very few neighbors who aren't tapped into the right organization. As mentioned, Escala is a block away from this project and is part of the Downtown Residents Alliance but its owners were completely unaware of the new project or that outreach was happening.

A single business owner may or may not be compelled to open a plain envelope addressed simply to 'neighbor.' However in a building with 200+ residents, it is all too easy for that same anonymous letter to be lost or perceived as junk mail and filed in recycling.

Bottom line, if the mailer is missed, early outreach to all neighbors falls apart. Hopefully the Department of Neighborhoods will clarify this process to require mailers to be sent to each residential unit within 500' or have the applicant personally communicate with a manager or HOA representative in each residential building within 500' of the project.

Meanwhile, Escala is particularly interested in the project's Transportation/Environmental design and it appears there is a committee for this. We will attend any and all meetings virtual or in-person. Please let us know when the first meeting is. For the time being please consider me the contact.

Thank you also for the info on the 1915 Third Ave. project. I don't see an owner email for that project and would appreciate it if you could forward me a contact so we can reach out directly to find where they are in the outreach process.

Thank you for your email. We have started the Community Outreach process for 2033 4<sup>th</sup> Ave but it sounds like from your email there is potentially gaps in the process - which can give the appearance of 'avoiding detection'. That is not our intention.

To clear up any confusion here is a detailed outline of the 2033 4<sup>th</sup> Avenue Community Outreach process so you are in the loop and aware of where we are in the process. Hopefully, you will see that it is our goal to follow the City's protocol, involve the community in the design process and welcome feedback from the local community members, such as yourself, throughout this process. We feel community involvement in the design process can only improve a project.

We took the kick off step of the City of Seattle community outreach process by posting on the Early Outreach for Design Review Projects Blog on August 24<sup>th</sup>.

As you know, there are multiple requirements of the City's Community Outreach process with the Early Outreach for Design Review Projects Blog post being the first required step. For the subsequent steps, the project's Community Outreach Plan proposes the high-impact outreach methods of providing a Direct Mailer, posting an Online Survey and hosting a Focus Group. Here is some more detailed information about the timing and approach to each of these three outreach methods:

**1. High Impact Printed Outreach Method: Direct Mailer to residences and businesses within a 500ft radius of the site.**

On 9/1, we mailed out a copy of the attached direct mailer to all addresses within 500 ft of the site that we obtained by the method set forth by the City from the King County iMap. The mailing list included the Escala building located at 1920 4<sup>th</sup> Avenue, so it should have reached the Escala offices by 9/4 or 9/7. Please note all direct mailings are all addressed to 'neighbor' and not to a particular person. It is our intent with this mailer to notify residents within the 500ft radius of the site of this project. Now that we are aware it did not make it to the residents at the Escala building, we would greatly appreciate it if you could send us the email contact information for the Escala building manager or HOA representative so all future correspondence cannot be 'missed' as junk mail and be forwarded to all residents that are interested. We would appreciate any help you can give us to make sure the Escala's contact information is correct.

**2. High Impact Electronic/Digital Method: Online Survey**

In the direct mailer that was sent out is an invitation to the community to participate in an online survey and a link to the survey was included. The link to the survey is <https://www.surveymonkey.com/r/TMDPTMP>. The online survey went live on September 1<sup>st</sup>. The intent of the online survey is to collect project specific visioning and design ideas from the community on what you would like to see implemented in into the design of the project.

The City requires this online survey be live and accessible for at least 21 days from the date of notification of the survey. However we have left it live as we feel this is a great way to collect a helpful information to our design process for the building. It will stay live for at least one more week after the date of this email.

**3. High Impact In-Person Method: Community Focus Group open to representatives of community organizations identified by the Department of Neighborhoods.**

We are currently in the process of preparing for Community Focus Group to be held in mid-October. We have tailored the project design and presentation for this meeting to address comments from the previous design. The plan for the Community Focus Group is to get feedback from the community on the preliminary design concept for the building, on the preliminary streetscape design, and on this new building's presence in the skyline. We especially wanted to make sure to discuss the latter topic with the Focus Group since we understand there were concerns shared about the previous design's impact on the skyline. We are inviting representatives of the community organizations on the attached list as identified by the Department of Neighborhoods. However, we would like to also invite a representative from the Escala HOA to the Focus Group meeting so we may hear feedback on these topics. If you are amenable, please provide the name and email address of the HOA representative who would like to attend this Focus Group and we will send them an invitation.

As a clarification, the Focus Group meetings are typically held in-person. However, the City has provided us with a Phase 3 Covid-19 ordinance update to the community outreach process in response to the pandemic. This update to the process allows for one high-impact digital method to be used in lieu of the required in-

person method to keep people safe. However, we feel that one of the best ways to get meaningful feedback from the community is by using the method of the Community Focus Group. So, to keep with the City's Phase 3 Covid-19 ordinance while still conducting the 'in-person method' of the Community Focus Group, the meeting will be held online instead of in-person to ensure people will feel comfortable and safe attending during the Covid-19 pandemic.

Please feel free to reach out to us with any questions about the Community Outreach Plan as we are managing it for this project. We look forward to receiving contact information from you for the Escala management and/or HOA representative. Please feel free to forward this link for the online survey to anyone you think should see it.

As for 1915 3<sup>rd</sup> Ave, yes we the Architect but we are not managing the Community Outreach process. The process that project is being managed by the Owner. We have let me know you are looking for more information but reaching out to them directly again is also a good idea.

On behalf of neighbors at Escala Condominium located one block from #3025502 at 2033 4th Ave., On 9/7/21 I emailed the project's Early Outreach contact (copied here) using the email address provided in the [Early Outreach Design Review Projects Blog](#). I asked to receive project information and provide feedback during the early engagement period but never received a reply.

I now see on the project portal a timeline (see attached screenshot) that says all residences and businesses within 500' of the project were sent a direct mailing that should have been received by Aug. 30th. The property manager at Escala can find no one in the building who received this mailing. Was it sent to all residents or a single postcard to the entire building? How were the mailer(s) addressed and what did they look like?

The second required outreach described in the portal is an online survey that would have concluded this week. The portal states the survey was advertised in a poster. Where was the poster posted? Was there more than one poster? The information in the project portal lacks any mailing lists, posting addresses or visual samples of these outreach methods and materials.

The final requirement for this project's early outreach is a focus group of neighborhood community groups identified by DON to be held sometime in October. Escala is a founding member of the [Downtown Residents Alliance](#) listed on DON's [Neighborhood Snapshot](#) page for Downtown. Again, there has been no outreach to the DRA or Escala.

This project seems to be following a public outreach strategy designed to avoid detection yet check the required boxes. Escala spoke out earlier this summer on project #3028017 which followed a similar stealth strategy. In this case the project received no public responses, which seemed to be its goal.

As with #3028017, an earlier version of #3025502 may have started the Design Review process before the City instituted the Early Outreach program. However, if the project is required to engage the public now, it should conduct the process in good faith and respond to public requests.

Additionally, on 9/7/21, I requested to be included in the Early Outreach process for 1915 3rd Ave. in an email to **Contact Information:** [19153rdAveProject@earlyDRoutreach.com](mailto:19153rdAveProject@earlyDRoutreach.com) This project shares the same architect as #3025502 and again, I've never received a response.


Can you please answer the process questions above on how #3025502 outreach was conducted and whether SDCI and DON consider this acceptable, good faith compliance? Also, what is the status of early community engagement for 1915 Third Ave?

Escala wants to participate in the early engagement process for both these proposals. What do we have to do to make that happen?

Dear Director Torgelson and Council Member Strauss,

For the third time in recent months another downtown tower has completed Early Community Outreach with virtually no public input.\* This is by design, not coincidence or lack of public interest.

I live two blocks from 1915 Third Ave and have followed this project over four years through the project portal under its original number #3023025. Until I saw it on the Early Outreach blog I was unaware it was now being required to undergo Early Design Outreach. The Early Outreach Blog does not provide project numbers or outreach timelines so there was no reason to think this portal number wouldn't provide the latest project plans and notices. But unlike two similar revised projects required to perform Early Outreach, 1915-3rd Ave was given a new number.

My 9/7 email asking to participate in the project's early outreach went unanswered. Responding on 9/23 to my follow up email, the project architect could have told me then that early outreach for 1915-3rd Ave. was completed in August and she had submitted a new design under a new project number in April, *three full months before* early outreach even began. That seems to contradict the program's goal to **"require developers to begin conversation with community members before building project designs are complete."**

Instead the architect said she wasn't handling this project's outreach and advised me to contact the owner but offered no information. SDCI staff on that email should have been aware of this and could also have told me the new project number and status but they said nothing.

Continuing the game of public 'keep away' the project is requesting SDCI internal Administrative Review reasoning that it qualifies by not counting six of its 15-stories because they are part of the original building incorporated into the design.

It's clear this development team has no use for public comment and believes SDCI's internal review is more likely to grant its many requests for departures and exceptions including extra building height and width, irregular tower separation and omitting the required loading berth.

Recent community outreach campaigns for #3028017, #3025502 and #3037644 have followed the same process and failed to engage the general public. #3025502 and #3037644 didn't respond to requests to participate until SDCI and elected officials were copied. Is this acceptable to SDCI and the Land Use and Neighborhoods Committee? If not, are you willing to fix the problems and make sure all stakeholders are part of a real community engagement process?
